# Introduction

The Kaduna Open Government Partnership (OGP) State Action Plan 2024-2025 is a two-year roadmap that renews Kaduna State's pledge to embed transparency, accountability and citizen-centred governance across the public sector. Co-created by the Planning and Budget Commission, other executive MDAs, the State House of Assembly, oversight bodies and more than 100 civil society and community Organisations, the plan aligns with the state's SUSTAIN Agenda and its long-term Open Government Strategic Vision of "nurturing citizen engagement for inclusive, people-oriented development".

Five priority commitments structure the Action Plan:

- 1. Strengthening the participatory budget process:** ring-fencing at least 5% of capital spending for community-nominated projects and publishing timely budget and audit data to let citizens track delivery.
- 2. Scaling up Open Contracting:** upgrading the state's e-procurement platform from OCDS to the Open Contracting for Infrastructure Data Standard (OC4IDS) and reviving the Public Procurement Board to tighten oversight.
- 3. Institutionalising access to information:** domestication of a Freedom of Information law and enhancement of the "Eyes & Ears" feedback tools so residents can request data and lodge service-delivery complaints in real time.
- 4. Strengthening social-protection systems:** operationalising a state social register, creating a social-security trust fund and expanding pro-poor programmes to curb multi-dimensional poverty.
- 5. Improving service delivery in education and health:** opening procurement and performance data for both sectors, empowering community accountability mechanisms and ensuring inclusive, gender-responsive facilities and curricula.

Each commitment runs from February 2024 to December 2025 and is backed by dedicated budgets, clear milestones and joint government-CSO implementation teams. Across the five areas, the plan advances the core OGP values of transparency, public participation, accountability and technology-enabled innovation while explicitly mainstreaming inclusion, particularly for women, youth, persons with disabilities and the poorest households. Together, these interventions are expected to deepen public trust, deliver better services and ensure that public resources translate into tangible improvements in the lives of Kaduna's citizens.

## Commitment Description

### 5. Problem

Despite citizens ability to nominate needs into the annual Budget in a timely manner through the automated citizens demand portal, there has been significant challenge in the implementation of these projects. This is because there is absence of a dedicated ring- fenced amount or a dedicated percentage of capital expenditure to accommodate these needs. There is need to strengthen participation of citizens around the Budget by empowering citizens to influence the budget in terms of citizen's needs implemented. Publication and implementation of audit recommendations is usually done but not in a timely manner.

### 6. Status quo

- i. Automated CDC process for needs across the 23 LGAs to inform the Annual Budget.
- ii. Lump sum provision for CDC in the budget.
- iii. Budget Call Circular has mandated MDAs to ring-fence 5% of its capital expenditure.
- iv. Townhall and public hearing engagements available for citizens to make inputs into the Budget.
- v. Citizens engaged during multi-year MTEF document based on the Fiscal Responsibility Law 2016
- vi. Audit recommendations published but not in a timely manner

### 7. Action

This commitment will ensure that citizens participate in the Budget process and can clearly identify CDC needs in the Budget. This will improve participatory Budgeting through monitoring and reporting for advocacy for improved service delivery. It will also guarantee that budget planning, implementation, monitoring and reporting meet the expectations of citizens and citizens have access to budget information in a timely manner and in acceptable format.

**8. How will the commitment contribute to solving the public problem?**

Participatory budgeting will sustain citizens engagement around the budget circle and ensure full utilization of the Community Development Charter through the Citizens Demand Portal as an effective participatory budgeting tool. By making budget inputs and information available, citizens can clearly identify needs that were captured in the annual Budget from their local communities and they can track and provide feedback on implementation. This empowers citizens to determine the kind of development desired in their local communities and ultimately build trust between citizens and government in a transparent manner for ownership and sustainability of the process.

## Commitment Description

### 5. Problem

Public procurement and infrastructure development processes suffer from a lack of transparency, leading to inefficiencies, corruption risks, and diminished public trust. Traditional methods of disclosing information, often paper-based and fragmented, hinder effective monitoring and analysis of government spending and project execution which can lead to huge financial losses. These shortcomings underscore the need for standardized solutions.

The Open Contracting Data Standard (OCDS) and Open Contracting for Infrastructure Data Standard (OC4IDS) address these challenges by establishing common data formats and structures for disclosing information related to contracting and infrastructure projects, respectively. By standardizing and streamlining data disclosure, these standards aim to make government processes more transparent, accessible, and accountable. They empower stakeholders to scrutinize and analyze procurement and infrastructure projects systematically, fostering fair competition, preventing corruption, and ultimately enhancing the efficiency and integrity of public spending but their adoption usually requires a significant investment in digital infrastructures and capacity building of such and with a very tight fiscal space, governments find very hard to adopt.

### 6. Status quo

Over the past five years, the Kaduna state government, under the auspices of the Kaduna Public Procurement Authority, has implemented the Open Contracting Data Standard (OCDS). This strategic move has significantly enhanced transparency in the procurement processes in the State.

The adoption of OCDS in Kaduna has revolutionized the way information about government contracts is disclosed and made accessible to stakeholders and the public. By adhering to OCDS principles, the procurement authority has standardized the format and structure of data related to the entire contracting lifecycle.

One of the notable outcomes of this implementation is the increased visibility into government procurement activities. The standardized data format has made it easier for citizens, civil society organizations, and businesses to access, understand, and analyze information about government contracts. This transparency not only promotes accountability but also serves as a deterrent to corruption, as the public can now actively monitor and scrutinize the use of public funds.

However, there is a need for improvement in terms of adherence to the data standards, integration with other portals, timeliness, completeness and accuracy of procurement data on the OCDS portal.

## 7. Action

This action plan is designed to enhance the existing OCDS portal, transforming it into an OC4IDS Portal. The primary objective is to augment the accessibility of procurement data, foster improved communication, and raise awareness of the portal across diverse community structures. Furthermore, the plan incorporates a robust feedback and grievance redress mechanism to ensure heightened awareness and optimal usage of the portal.

The initiative places a significant emphasis on engaging civil society organizations (CSOs) as pivotal stakeholders. These organizations will play a crucial role in harnessing the published data to advocate for enhancements in public procurement procedures and overall service delivery. By leveraging the power of civil society, the action plan seeks to create a more transparent and accountable procurement landscape, thereby contributing to the broader goal of good governance.

In addressing governance concerns, the action plan goes beyond the technological upgrade of the portal. It takes a proactive stance by advocating for the reinstatement of the Public Procurement Board, which has been inactive since 2019. The revival of this institution is seen as essential for reinforcing checks and balances in the public procurement process, ensuring its integrity and adherence to ethical standards.

## 8. How will the commitment contribute to solving the public problem?

The commitment to adopting and implementing the Open Contracting Data Standard (OCDS) and Open Contracting for Infrastructure Data Standard (OC4IDS) plays a crucial role in addressing the persistent challenges in public procurement and infrastructure development. The commitment contributes to solving the public problem in several ways:

**Enhanced Transparency:** OCDS and OC4IDS establish standardized and streamlined data formats for disclosing information related to contracting and infrastructure projects. This commitment ensures that procurement and infrastructure data are presented in a consistent and transparent manner, mitigating the opacity that often leads to inefficiencies and corruption risks.

**Improved Accountability:** By adhering to OCDS and OC4IDS, the commitment promotes accountability in government processes. Standardized data disclosure empowers stakeholders, including citizens, civil society organizations, and businesses, to systematically scrutinize and analyze procurement and infrastructure projects. This scrutiny acts as a powerful accountability mechanism, deterring corrupt practices and fostering responsible use of public resources.

**Efficient Monitoring and Analysis:** The commitment addresses the limitations of traditional, paper-based, and fragmented disclosure methods. OCDS and OC4IDS provide systematic tools for monitoring and analyzing government spending and project execution. This not only enhances the efficiency of public spending but also allows for better decision-making and resource allocation.

Prevention of Corruption: Standardized data disclosure under OCDS and OC4IDS helps prevent corruption by creating a more level playing field and reducing the opportunities for irregularities. The commitment contributes to building a procurement and infrastructure development environment where fair competition is encouraged, and potential corruption risks are systematically identified and addressed.

Public Trust and Engagement: As the commitment leads to increased transparency and accountability, it contributes to rebuilding and strengthening public trust in government processes. When citizens have access to clear and standardized information, they are more likely to engage actively in public affairs, fostering a sense of ownership and participation in governance.

Strategic Resource Allocation: The commitment, by adopting OCDS and OC4IDS, allows for more strategic resource allocation. Governments can make informed decisions based on systematic analysis of procurement and infrastructure data, ensuring that resources are allocated efficiently to projects that yield maximum public benefit.

There is insufficient citizens' engagement, participation, and feedback in the budget implementation due to the absence of legal framework through the Freedom of Information Law in the State. Despite having the Eyes and Ears citizens engagement feedback tools, the upgrade and integration with other systems has reduced citizens access to updated information. This results in citizens not having adequate information and thus, not being able to relate with projects in the budgets which ultimately weakens accountability.

In the first action plan, the state created feedback tools for receiving citizens' feedback and expanded the tools to include WhatsApp, Gani Ya kori Ji Hausa Radio programme, Facebook and writing to the Commissioner Planning and Budget commission directly. The desire is to strengthen available online platforms to provide citizens with access to relevant information about government

activities and policies as well as improving the systems in general to address tech infrastructure gaps. This platform will also provide an avenue for citizens to provide feedback and make suggestions without restrictions.
